New Owners Acquire Forever 21 Out of Bankruptcy

Following the bankruptcy filing of the Los Angeles-based Forever 21, the apparel chain was acquired by Authentic Brands Group, the Simon Property Group and Brookfield Property Partners. ABG and Simon each own 37.5 percent of the business with Brookfield owning 25 percent of Forever 21's operating business and intellectual property. Plans are to negotiate new leases for the US stores and move stores in Central and South America, Mexico, the Philippines and the Caribbean to a licensed partnership mode. Future plans call for opening new stores across South America, Europe, China, Southeast Asia, the Middle East and India.

Hanesbrands Receives Two CSR Awards in Latin America

For the ninth consecutive year, Hanesbrands received a 2019 FUNDAHRSE Seal from the Honduran Foundation for Corporate Social Responsibility. The award recognizes the company's efforts in seven key areas: corporate governance, employee relations, environmental sustainability, responsible marketing, supplier standards, community relations and public policy.

In addition, Hanesbrands was honored by the Mexican Center for Philanthropy with its seventh CEMEFI award for the company's focus on promoting "a more equitable, supportive and prosperous society" across Latin America. Hanes earned the award for its back-to-school program, an initiative that has operated in the Dominican Republic since 2008. The program distributes school kits to children of employees and to those who attend public schools in communities where the company operates. To date, the company has donated 106,000 kits, which include a backpack, notebooks and other needed supplies, that help children be successful in school.

Quick Rebound on China Economy Predicted After Coronavirus Subsides

The managing director for China for global consultancy Roland Berger, Denis Depoux, predicted that the Chinese economy will quickly rebound after the coronavirus subsides just as it did after the SARS crisis. He foresees that inventory, restocking and consumption of goods and services will recover quickly. A growing number of manufacturers such as Honeywell and Asia Pulp and Paper have already resumed operations.

Cambodia Loses \$1.1billion in EU Trade with Loss of EBA Preference

On February 12, the European Union revoked part of Cambodia's trade preference program called Everything but Arms (EBA). The EU is Cambodia's largest trading partner and the loss of \$1.1billion in duty free access to the EU, or about one-fifth of Cambodia's exports to the EU with garments, shoes and sugar being hit the hardest. The garment sector alone employs 800,000 workers in 1,200 factories, with 85% of the workers being women. The Cambodian footwear industry described the move as a "dramatic setback". There is a strong likelihood that some factories will close and foreign investors will look elsewhere.

EU and Vietnam Agree to Free Trade Agreement

On February 12, the EU Parliament approved a free trade agreement between Vietnam and the EU which will allow all goods traded between the two countries to pass duty and quota free. The agreement also contains strong protections for labor rights, sustainable development, environmental protection and the Paris Agreement on climate. The agreement will go into effect in 2020 as soon as it is ratified by Vietnam.

Cambodia Plant Closings Likely as Closed China Plants Can't Deliver Materials

Most fabric used in sew plants in Cambodia is sent from China. In anticipation of the Chinese New Year, factories ordered extra fabric with the plan to begin receiving fabric after the Lunar New Year. But the onset of the Coronavirus extended the New Year holiday and has closed hundreds of textile plants which will mean factories will start shutting down in March as they run out of supply. The government and unions are concerned about the possibility of layoffs and plant closings.

Cambodia PM Promises Tax Relief and Wage Support for Virus Outbreak

Prime Minister Hen Sun promised a tax break of six months to garment factories which are affected by the coronavirus outbreak and higher tariffs. In addition, for laid off workers due to the disruptions, factories will pay 40% of the workers' wages and the government will pay an additional 20%.

Myanmar Factories in Dire Straits with Loss of China Textile Supplies

Up to 90% of garment inputs at Myanmar factories come from China with Indonesia, Vietnam, Thailand and South Korea making up the rest. The ongoing coronavirus is spelling trouble for the 500,00 garment workers working in the Yangon region. Normal overtime during the week and weekends has stopped due to lack of supplies. The Myanmar Garment Manufacturers Association said that by mid-March, supplies will run short and factories will start closing.
